All the Medicines required should be supplied by the suppliers. Medicines of Reputed Companies i. e. Reputed brands must be preferred over Generic brands.**

No conditional Tender (s) shall be accepted.



Analytical Test Certificate of medicine etc. will have to be submitted at the time delivery.



In case of failure of supply at the accepted rate, the supply will be cancelled and earnest money so deposited will be forfeited.
